 - Appoint Seats 9 and 10 to ICANN Board
 - Appoint individuals to ICANN bodies
 - NomCom 2012 Hartmut Glaser (LACNIC)
 - SSR Review Team Hartmut Glaser (LACNIC)
 - WHOIS Policy Review Team Wilfried Woeber (RIPE)


What is the NRO?

- Number Resource Organization
 - Vehicle for RIR cooperation and representation
- Formed for the purposes of:
 - protecting the unallocated Number Resource pool
 - promoting and protecting the bottom-up policy development process
 - acting as a focal point for Internet community input into the RIR system
- Fulfills the role, responsibilities and functions of the ASO within ICANN framework
 - By ICANN/ASO MoU signed on 21 October 2004

ASO / NRO

- NRO expenses distribution 2011
 - Weighted formula (being currently reviewed) based on revenue and total number resources held:
 - AfriNIC (4.14%)
 - APNIC (37.50%)
 - ARIN (18.17%)
 - LACNIC (6.86%)
 - RIPE NCC (33.45%)
- NRO contribution to ICANN
 - The NRO remains committed to a yearly contribution of \$823,000.



ASO Address Council

- Function performed by NRO Number Council
- 15 Community Members
 - 3 from each RIR Region (2 elected, 1 appointed)
- Independent body separate from RIR management and board to:
 - Oversee global number resource policy work
 - Appoint 2 Directors to the ICANN Board
 - Serve on various ICANN bodies as needed:
 (e.g. ICANN Nominating Committee, Affirmation of Commitment Review Teams)
 - Advise ICANN Board on number resource matters

Independent Review of ICANN ASO

- Request for Proposal
 - ITEMS International, a Paris-based consultancy firm specialized in strategic consulting in the areas of telecommunications and the Internet
- Aims
 - Assess how well the ASO performs within the ICANN system
 - Determine whether any change in its structure or operations is desirable
- Conducted between July and December 2011
 - A global survey
 - Individual interviews at ICANN and RIR meetings



Independent Review of ICANN ASO

- ASO Review Report published 14 March 2012
 - Available on aso.icann.org
- Next Steps
 - ICANN Public Comment Process
 - NRO welcomes comments, and will post our final recommendations during the comment reply period
 - ASO Review Report with comments/replies will go to the Structural Review Committee and ICANN Board





Status of GPP-IPv4-2011

Global Policy Process





ASO AC: GPP-IPv4-2011

- "Global Policy Proposal for Post Exhaustion IPv4 Allocation Mechanisms by IANA"
- Recognized by ASO AC as GPP candidate 3 February 2011
- Describes how IANA will allocate IPv4 resources now central pool is exhausted
 - Establish a Recovered IPv4 Pool
 - Remaining fragments and returned space
 - 1/5 of Recovered IPv4 Pool to each RIR every IPv4 Allocation Period (6 months)



Global Policy Process

- GPP Process defined by ASO MOU

- Attachment A GPDP

- ASO AC Operating Procedures
 - http://aso.icann.org/documents/operating-proceduresaso-ac/
- Calls for Policy Proposal Facilitator Team (PPFT)
- Within sixty (60) days AC will either
 - Pass to ICANN for ratification as a global policy;
 - Advise the NRO EC of any concerns; or
 - Request the NRO EC for a time extension



GPP-IPv4-2011 Status

- In Ratification Phase
 - NRO EC transmits to ASO AC Completed
 - Address Council Review Completed
 - Address Council notification to ICANN Completed
 - ICANN Board Ratification:
 - Actions within 60 days: accept, reject, request changes, take no action
 - Open comment period as required by ICANN bylaws

AfriNIC Policy Update

- Recently Approved
 - AFPUB-2011-v4-004 (GPP-IPv4-2011)
 - Global Policy for Post Exhaustion IPv4 Allocation Mechanisms by the IANA
 - AFPUB-2010-v4-005
 - IPv4 Soft Landing Policy
 - Changes IPv4 policies to deal with exhaustion
 - Maximum size of each allocation or assignment is reduced, first to /13 and later to /22
 - Time window used for planning purposes is reduced
 - A /12 is reserved for unforeseen purposes
 - AFPUB-2010-GEN-006
 - Abuse Contact Information in the AfriNIC service region
 - Adds a way of recording abuse contact information in WHOIS data

 - AFPUB-2011-v4-001
 - Transfer of IPv4 Addresses to Any Entity

 - AFPUB-2010-v4-003 (GPP-IPv4-2010)
 - Global Policy for IPv4 Allocations by the IANA Post Exhaustion

 - ARIN-2012-4 Return to 12 Month Supply and Reset Trigger to /8 in Free Pool

 Initial Allocation
 - 2011-05, Safeguarding future IXPs with IPv4 space



STATUS OF 256 /8s IPv4 ADDRESS SPACE






IPv4 ADDRESS SPACE ISSUED

(RIRs TO CUSTOMERS)


In terms of /8s, how much space did each RIR issue by year?





IPv4 Address Space Issued (RIRs TO CUSTOMERS)


In terms of /8s, how much total space has each RIR issued? (Jan 1999 – Dec 2011)





ASN ASSIGNMENTS (RIRS TO CUSTOMERS)


How many ASNs has each RIR assigned by year?


How many total ASNs has each RIR assigned? (Jan 1999 – Dec 2011)





4-BYTE ASN ASSIGNMENTS


How many 4-byte ASNs has each RIR assigned by year?





4-Byte ASN Assignments


How many total 4-byte ASNs has each RIR assigned? (Jan 2007 – Dec 2011)



Allocations made by each RIR by year?







IPv6 Allocations RIRs to LIRs/ISPs

How many total allocations have been made by each RIR?




In terms of /32s, how much total space has each RIR allocated?


