- Global policy proposal certification
 - Excerpt from Attachment A of the ASO MoU:
 The ASO Address Council shall review the process followed by the RIRs in terms of reaching a position of common agreement and a common text to describe the proposed global policy, and the Address Council shall undertake measures in accordance with an adopted procedure to assure itself that the significant viewpoints of interested parties were adequately considered.

Activities of the ASO Address Council (continued)

- Working to increase ICANN community communication
 - ICANN 39, Dec 2010
- Global policy proposals
 - ASN Allocation (ARIN 2009-6): ratified Sep 2010
 - IPv4 return & redistribution (ARIN 2009-3): *lost global policy status*
 - IPv4 redistribution post run-out (ARIN 2010-10): active

Draft Policy 2009-3 (Global Proposal): Allocation of IPv4 Blocks to Regional Internet Registries

- Tried to address two things
 - Ensure that IANA has a policy to allocate addresses after the exhaustion phase. Ensure IANA can allocate left over
- ARIN AC rewrote policy to make the returning of addresses to IANA optional

 Policy proposal with substantial containing ARIN region
 - Policy proposal with substantial contextual change accepted in ARIN region
 PNIC, LACNIC, AfriNIC accepted the policy as written
- APNIC, LACNIC, AfriNIC accepted the policy as written
- RIPE NCC awaiting decision from proposal authors
 - No community consensus
 - Awaiting ARIN decision on this policy
